

12 Days of Christmas Giveaways Official Rules

WHEN TO ENTER: NO PURCHASE NECESSARY. The “12 Days of Christmas Giveaways” promotion begins at 11:00am CST on Tuesday November 30th 2021 and ends at 7:30am CST on December 17th 2021. HOW TO ENTER: Registration boxes are out and available for you to sign up/enter at the following locations; Rucker Lanes, BOSS building, Mother Rucker’s, Center Library, The Landing Zone, Building 5700- Soldier Service Center Lobby, Main PFC and Silver Wings Golf Course.
